




**FORMAT OF AFFIDAVIT TO BE SUBMITTED BY THE INSTITUTION ON RS. 100/-
STAMP PAPER WITH REGARD TO FACULTY**

I, **Prof. Gurmail Singh** son of **S. Randhir Singh** aged 71 years, resident of **House No. 1012, Sector 15 Chandigarh**, in the capacity of **Vice-Chancellor** (or any authorised person of the Management) of Akal University (Name of the Society/Trust with complete address as in the society registration papers) take oath and state as under:-

1. That I am the **Vice-Chancellor** (or any authorized person of the management) of Akal University (Name of the Society/Trust with complete address as in the society/trust registration papers) and signing this Affidavit on behalf of it for which I am fully authorized.
2. That the managing society/trust has made an application to the NRC, NCTE for running an institution, namely Akal University Talwandi Sabo, Bathinda (name & address of the institution) for **ITEP (B.A.-B.Ed)** (name of the course) with an intake of **50 Students**. The institution after fulfilling all the provisions of the NCTE Act, Rules & Regulations has got Letter of Intent under clause 7(13) of the NCTE Regulations, 2014 vide NRC, NCTE letter No. **NCTE/NRC/2627202509162520/PUNJAB/2025/LOI** dated **23.01.2026**.
3. That the managing society/trust of the institution has constituted the Selection Committee for appointment of faculty as per the policy of the State Government/University/UGC.
4. That the following faculty members have been appointed by the duly constituted selection committee having requisite qualifications and experience as prescribed in NCTE Regulations. Details of qualifications and experience are given in Annexure – 1.
5. The staff has joined/shall join the duty in the institution and will not be permitted to serve in any other institution on regular basis without appointing eligible teacher/principal and the same will be intimated to the affiliating body and NRC-NCTE, Jaipur.
6. That the academic staff of the institution (including part-time staff) is/shall be paid salary in such scale of pay as prescribed in the UGC/University/affiliating body from time to time. The supporting staff shall be paid as per the UGC/State Government/Central Government pay scale structure.
7. That the society/trust has appointed required number of Technical support staff and Administrative Staff of the requisite qualifications and experience as per norms and standards laid down by NCTE/State Government/Affiliating body. Salary is being/shall be paid to the staff members through bank/account payee cheque as prescribed by the NCTE.
8. The management of the institution shall discharge all the statutory duties relating to pension, gratuity, provident fund, etc for its employees as per the admissibility. The institution shall follow the norms of the NCTE as amended from time to time.
